

AGREEMENT

for collaboration in fields of public health and medicine between:

(in the text bellow agreed sides, represented by their managers), in spirit of friendship, helping each other in bilateral cooperation, with willing to make cooperation in field of health and medicine, as a common benefit, agree following:

Art.1

The agreed sides on base of equality, reciprocity and bilateral interest will develop and initiate collaboration in field of health and medicine.

Art.2

Both sides will cooperate in following priority areas:

1. Helping in organizing of health system
2. Supporting medical health care services in diseases.
3. Medical sciences.
4. Supporting and developing emergency medical services.
5. Supporting in improving professional skills.

Collaboration in areas mention above doesn't except cooperation in other fields.

Art.3

The both side's make agreement providing following:

1. Exchanging information about health affairs.
2. Training of professional medical stuff, logistic medical stuff, hospital managers and others
3. Direct contacts among two institutions
4. Developing a projects, topics and deferent solutions of common benefit.
5. Exchanging of teaching and administrative stuff.
6. Other forms of agreement in comprehensive health and medical areas.

Information that uncovers top or state secrets, or could make damages in working process of both subjects isn't under consideration of this agreement and shouldn't be objects of exchange.

Art.4

The both sides should inform each other for medical events with international attendance in their countries. Along with this would be send announcements which refer to any international medical congresses and symposiums sustained in both countries.

Art.5

The agreed sides will initiate exchanging of doctors, docents, university professors and other stuffs cooperating in particular issues. The number of changed persons will be determinate according to previously made arrangements.

Art.6

The agreed sides apparently will make memorandum for all activities in which they will confirm forms, contents, methods, conditions for collaboration in certain range of time. They will provide financial plan for successful realization of relevant activities and scheduled steps.

Art.7

For realization of this agreement the agreed sides will form commission consist of 6 members, 3 of each side. The commission will make appointments at least once a year, and the place of meeting for each one will be defined according to actual conditions and possibilities.

Art.8

All exchanged information and forms of collaboration based on this agreement will be appropriately realized under national legislation of both countries.

Art.9

The both sides will coordinate their activities in the frame of WHO legislation, and others international organizations whit which they collaborate in health area.

Art.10

This agreement becomes valid on the day of its assign and lasts for period of 5 (five) years, after which it would be automatically continued for another 5 (five) years. The agreement could be interrupted by each of the sides only in written form, technically with written letter of information, in time period more than six (6) months before moment of interrupting.
